If your school does not issue a valid (yearly) student photo ID cards or participates in an CCRTA Transportation Program you may still be eligible for Student Discounted Fares. Simply fill out this Student Photo ID Card application and pay a \$3.00 fee for a student photo id card. This student photo ID card will entitle you to student Discount Fares on CCRTA Fixed Route Services for 1 full year. New application and fee of \$3.00 is needed each year to receive a new student photo ID card.

All students must be enrolled as a full-time student at a High School, Private School, Charter School, College, University, Trade School or Technical School within the CCRTA Service Area. Students may be also eligible for discount fares and student discounted passes for CCRTA Fixed Route Services only.
