Notice is hereby given that the Board of Directors of the Corpus Christi Regional Transportation Authority of Corpus Christi, TX (CCRTA) will hold a public hearing on Wednesday, December 7, 2016, at 8:30 AM to receive public comment regarding proposed January 2017 Service Improvements. The proposed changes include the following bus routes: 4, 12, 12S, 16, 17, 27, New Route 28, Route 29, New Route 30, 32, 32S, 34, New Route 35, New Route 54, 55, New Route 56, 65, 67, 76, and New Route 81.

Copies of proposed route maps and timetables will be available Monday, November 7, 2016, for public review at the following location: CCRTA Administration Building located at 602 N.
