Information for Older Americans (60+)/Persons with Disabilities

WHAT IS A "B" IDENTIFICATION CARD FOR OLDER AMERICANS /PERSONS WITH DISABILITIES?

A "B" Identification Card for Older Americans/Persons with Disabilities is a photo ID that entitles the rider to special fares on the regularly scheduled bus routes ONLY.

WHO IS ELIGIBLE FOR A "B" IDENTIFICATION CARD FOR OLDER AMERICANS / PERSONS WITH DISABILITIES?

Persons sixty (60) years or older and persons with permanent disabilities are eligible to obtain identification cards.

HOW DO I APPLY FOR A "B" IDENTIFICATION CARD FOR OLDER AMERICANS / PERSONS WITH DISABILITIES?

To apply for a "B" Identification Card for Older Americans (60+)/Persons with Disabilities for the regularly scheduled bus routes, complete the application form on reverse side.

If you are a person with a disability, it will be necessary for you to have a physician or agency complete the bottom portion of the application. Please be sure the doctor or agency completes the address portion of the application.

Other acceptable forms of disability verification accepted are Medicare & Social Security Awards letters.

To obtain the "B" Identification Card, you must take the completed application to the Corpus Christi Regional Transportation Authority Customer Service Center Office at 602 N. Staples Street. Office hours are Monday-Friday from 7:00 a.m. to 6:00 p.m.

HOW MUCH DOES AN OLDER AMERICANS/PERSONS WITH DISABILITIES "B" IDENTIFICATION CARD COST?

The first "B" Identification Card is free. Replacements cards are \$3.00.
