This Addendum No. 1 is issued to make the following changes to RFP No. 2024-S-05:

- 1. <u>The Corpus Christi Regional Transportation Authority (CCRTA) has modified the</u> RFP to include the below requirements of the awarded Contractor:
 - Upon award, the Contractor will be required to maintain an office within the city of Corpus Christi, Texas for the duration of the five-year contract.
- 2. The CCRTA has modified the fifth paragraph in Section 2.0 Project Description in the "Statement of Work" located on page 14 of 54 in the RFP to increase the yearly compensation and quarterly payment amounts for the Project Manager as follows:

Current Section 2.0 Project Description:

The Contractor will provide a Project Manager to oversee the contract. Compensation will be a flat payment of **\$20,000** yearly and paid in increments of **\$5,000** quarterly.

Revised Section 2.0 Project Description:

The Contractor will provide a Project Manager to oversee the contract. Compensation will be a flat payment of \$30,000 yearly and paid in increments of \$7,500 quarterly.

3. The CCRTA has modified Section 12.11 Billable Hours of Section 12.0 Report and Records in the "Statement of Work" located on page 29 of 54 in the RFP to increase the yearly compensation and quarterly payment amounts for the Project Manager as follows:

Current Section 12.11 Billable Hours:

\$20,000 yearly compensation for the Project Manager to be paid in increments of \$5,000 quarterly.

Revised Section 12.11 Billable Hours:

\$30,000 yearly compensation for the Project Manager to be paid in increments of \$7,500 quarterly.
